A Word From the Publisher

t's been 32 years since the trucking industry was officially "deregulated," which meant the federal government would no longer regulate freight rates and services. Passage of the Motor Carrier Act of 1980 unleashed powerful market forces that continue to reshape the industry today.

But trucking today is far from being unregulated. In fact, you could argue that it is more regulated than ever before.

How can that be? Consider that over the past three decades, in the name of highway safety, the federal government has mandated drug and alcohol testing and set minimum licensing requirements for drivers, funded state-run roadside inspection programs, increased by one hour the maximum time a driver can be behind the wheel and cut by one hour the maximum time a driver can be on duty. The Environmental Protection Agency set new emissions standards for heavy-duty diesel trucks, forcing the industry to adopt new and more expensive equipment.

And there's more on the way. Electronic logging devices, new training standards for drivers and medical examiners, new safety fitness ratings

for carriers and drivers, higher insurance and bonding requirements, new qualification standards for new carrier entrants, and much more.

What does this mean? Part of the answer can be seen in a report by Senior Features Writer Daniel P. Bearth for the 2013 TRANSPORT TOPICS Top 100 For-Hire Carriers feature.

Compliance with safety and environmental regulations are raising the cost of hauling freight, the consequences of which we may be just beginning to see and understand.

For some trucking executives, new regulations, such as a mandate for using electronic onboard recording devices to monitor driver hours of service, are necessary to ensure a level playing field for all carriers.

Steve Williams, chief executive officer of flatbed carrier Maverick USA in Little Rock, Ark., said he supports "anything that makes it hard to get into and hard to stay in this industry."

Carriers that are able to meet new regulations will be the ones that prosper in the future, according to Williams' point of view.

Not surprisingly, there are others who believe that federal oversight of trucking is going too far.

"We're the most over-reregulated industry out there," said Michael Card, president of Combined Transport Inc. and current chairman of American

Trucking Associations.

Card said the cost of meeting new regulations, such as driver hours-ofservice, drug testing and onboard recorders, will force many carriers out of business and will discourage others from starting up.

"They're all great regulations, but almost all of them have raised the cost of owning a trucking company," he said.

Regardless of your point of view, it should be noted that the trucking industry's safety record has improved considerably during this period. The number deaths in truck-involved crashes has fallen from a high point of 5.21 per hundred million miles traveled in 1979 to a low point of 1.03 per hundred million miles trav-

eled in 2009.

Can this safety record continue? The number of fatalities per hundred million miles traveled has gone back up slightly in the past two years, and the industry appears to be at a crossroads. Will aggressive new federal safety interventions help or hurt the cause? Will new technologies, such as anti-collision warning systems and in-cab driver monitoring, play a bigger role in preventing crashes?

The answer to those questions remains to be seen. But clearly, the time has come for everyone to acknowledge the price of progress.
